

Preamble

The Premier Volleyball League (PVL) is a volleyball competition which is offered annually to Affiliate and Associate Affiliates of Volleyball Queensland (Affiliates). The PVL comprises multiple graded Divisions for both Men and Women including open age and junior competitions.

These By-Laws address arrangements associated with Volleyball Queensland (VQ) Affiliates entering the PVL, the eligibility of players, requirements of participant teams and conduct of the competition. All Affiliates participating in the PVL, including their officials, Coaches and Team Captains are deemed to have agreed to these By-Laws

Competition dates, location, divisions offered and entry process will be available through the VQ website, www.vq.org.au.

1. COMPETITION FORMAT

- 1.1. The PVL will consist of one season played annually.
- 1.2. Entry is open to Affiliate and Associate Affiliates of VQ for the year of competition. (Nb affiliate status needs to be in place for PVL nominations to be accepted)
- 1.3. There will be up to five Divisions in each gender available: Premier, Divisions 1, 2 & 3 and Premier Junior (formerly U19A).
- 1.4. All Divisions are capped at a maximum of twelve (12) teams. Extra teams will be subject to court availability.
- 1.5. Unless otherwise listed in these By-Laws, the PVL competition is conducted in accordance with the official rules of FIVB as varied by Volleyball Australia (VA).

2. TEAMS

- 2.1. Affiliates can only enter a single team in Premier, Division 1, Division 2 and Premier Junior. An Affiliate may enter a second or third team in Division 3. VQ reserves the right to vary these conditions in exceptional circumstances.
NB Dependent on team entries into Division 3 it may be graded i.e. A & B or a Division 4 formed. Affiliates are to plan for this occurrence when selecting their rosters.
- 2.2. Each team's grading is determined by results from the previous year. If a team has not entered the competition previously, they can only enter lowest open Division or the junior Divisions.
- 2.3. For affiliates that seek to enter a team into Premier Division, that team must be underpinned by a Division 1 or a Premier Junior team of the same gender.
- 2.4. Single teams from Affiliates may be granted entry, subject to the discretion of VQ.
- 2.5. VQ reserves the right to refuse entry to any team.
- 2.6. VQ reserves the right to admit teams or vary entries in Divisions to ensure that a Division remains viable, optimal and team numbers are even (to avoid scheduled byes).
- 2.7. A maximum number of teams allowed to enter will be restricted depending on venue and time availability. The basis of priority for teams entering will be as follows:
 - a) First priority will be given to Affiliates fielding teams in all fourteen (14) PVL and Junior PVL (JPVL) Divisions.
 - b) Second priority will be given to Affiliates fielding teams in thirteen (13) Divisions and so on.
 - c) If Affiliates enter the same number of teams, priority will be given to the highest placed team from the previous year's results.

3. TEAM NOMINATION AND PAYMENTS

- 3.1. Team nominations must be entered through the entry process as provided at or from the PVL webpage in www.vq.org.au.
- 3.2. Following nomination, teams will be issued an invoice for payment of their team bond by the due date. This payment completes the team nomination process.

- 3.3. All team nomination fees are to be settled with VQ prior to round four (4) of PVL.
- 3.4. Teams who have not paid their competition fees by the due date will not receive competition points until the amount is paid. If fees are not paid within one (1) month of the scheduled date, each team playing for the club/association will lose all competition points in addition to having money deducted from their bond. Teams may also be excluded from the PVL due to outstanding debts to VQ.
- 3.5. Affiliates financial obligations, if they withdraw teams are;
 - 3.5.1 After close of nominations, 50% of the nomination fee is to be paid.
 - 3.5.2 After commencement of the PVL, 100% of the nomination fee is to be paid.

4. PLAYERS

4.1. ELIGIBILITY

- 4.1.1 For players to be eligible, they must be a current financial registered Full member of VQ, and the Affiliate they represent. There will be “Zero Tolerance” regarding unregistered players at any stage of the season. Registrations must be received by VQ prior to 11:59pm on the Wednesday before playing. Players deemed to be “under” registered i.e. Recreational instead of Full will have 1 week’s grace to update their registration correctly before penalties apply.
- 4.1.2 Transfers during the season must be completed, approved and submitted to VQ by midday Thursday for a player to be eligible to play for their ‘new’ club in the next round.
- 4.1.3 Player clearances are not applicable for PVL.
- 4.1.4 Men/boys are not eligible to play in women’s/girls competition matches and women/girls may not play in mens/boys matches.
- 4.1.5 Players in Junior Divisions must be under the stated age for the full calendar year of the competition.
- 4.1.6 All Affiliates have a duty of care to ensure that players are of an appropriate skill level for the Division in which they compete. The Venue Manager/ Chief Referee may determine if a player is not of an appropriate skill level and recommend the withdrawal of that player from the team list.
- 4.1.7 Any team fielding an illegal or ineligible player (e.g. unregistered, not transferred, under a false name, or not under the correct age for age limited Divisions) will forfeit that match.
- 4.1.8 Only those players named on the score sheet at the end of the match, and having entered the court during the match, will be regarded as having played.
- 4.1.9 Players may be added to the Team List during the match upon request and with the approval of the Venue Manager. At re-scheduled or mid-week matches hosted by Affiliates, this will be decided upon by agreement between the captains with the 1st Referee having the deciding vote, if required.
- 4.1.10 In the event of a forfeit due to incomplete team numbers, those listed on the score sheet and present at the scheduled start time, will be recorded as playing.
- 4.1.11 If an Affiliate has more than one (1) team in a particular Division, players may only participate in one (1) team all season.
- 4.1.12 Unless otherwise stated, eligibility By-Laws for the preliminary rounds, are also in effect for all finals matches.

4.2. PREMIER DIVISION ELIGIBILITY

- 4.2.1 Premier Division teams may use Division 1 or lower Division players.

4.3. DIVISION 1, 2 or 3 ELIGIBILITY

- 4.3.1 The “Top Eight” (8) players in Premier Division for each Affiliate are determined solely by cumulative court time throughout the PVL season.
- 4.3.2 The Top Eight players list will be established after Round 3 and will then be reviewed and updated weekly. This list will be sent to the Affiliates’ primary contact by 5:00pm on the

Wednesday following the completed round of fixtures. Clubs may request that one (1) other contact be added to this mailing list.

- 4.3.3 To determine players on this list that are eligible to play in Division 1, the following conditions apply:
- The top five (5) players on the list are ineligible.
 - Clubs must choose one (1) player from the remaining 3 players to be Premier Division only. The remaining 2 players are eligible to play in Division 1. None of the top 8 players are eligible for Division 2.
- 4.3.4 Liberos
- A Premier Division Libero is ineligible to play as Libero in Division 1 or lower Divisions in the same round but may play in any other position if eligible under (4.3)
 - Division 1, 2 or 3 Liberos are ineligible to play as Libero in Premier Division, but may play in any other position.
 - The Division 1 Libero is ineligible to play as Libero in Division 2 or 3 in the same round but may play in any other position if eligible under (4.4).
 - The Division 2 Libero is ineligible to play as Libero in Division 1 or 3 in the same round but may play in any other position if eligible under (4.4).
 - The Division 3 Libero is ineligible to play as Libero in Division 1 or 2 in the same round but may play in any other position if eligible under (4.4).
- 4.3.5 If an ineligible player is found to be playing in a Division 1, 2 or 3 match by the Competition Management, the Division 1, 2 or 3 team will forfeit the set/s in which the ineligible player takes part. The ineligible player will be excluded from further participation in the match. Where possible, the match should continue from this point.
- 4.3.6 If a Premier Division player is injured, a Club may submit a "PVL Injury Exemption Form" to permit a 'replacement player' to cover this injury period without impacting their Division 1, 2 or 3 status.
- 4.3.7 In the event of an injury, teams may apply by 5:00pm Wednesday prior to the match for a "one off" exemption from the PVL Competition Manager.
- 4.3.8 Any players included on the "Elite Player" List are not eligible for Division 1, 2 or 3.
- 4.3.9 Adult players that have represented the Senior National team in the preceding 12 months are not eligible for Division 1, 2 or 3. This does not apply to Junior players (U19) who are only ineligible for Division 2 or 3 or Junior Divisions.
- 4.3.10 Prior to the PVL Season commencing, VQ will publish a list of the "Top 10" female and male Queensland Pirates based on the previous year's AVL or like competition. Those players who are in the 'Top 10' and are NOT already excluded by the "Top 8/6" system are not eligible for Division 1, 2 or 3. Exemptions will be dealt with on a case by case basis.
- 4.3.11 Adult players that have been full-time members of the VA-COE-AVA Indoor and/or Beach Volleyball programs in the preceding 12 months are not eligible for Division 1, 2 or 3.

4.4. DIVISION 2 & 3 ELIGIBILITY

- 4.4.1 No player from the "Top 8" in Premier Division is eligible to play in Division 2 or 3.
- 4.4.2 The top six players in Division 1 (as based on cumulative court time) will be established after Round 3 and will then be reviewed and updated weekly. This list will be sent to the Affiliates' primary contact by 5:00pm on the Wednesday following the completed round of fixtures.
- 4.4.3 No player from the "Top 6" in Division 1 is eligible to play in Division 2 or 3.
- 4.4.4 No player from the "Top 6" in Division 2 is eligible to play in Division 3.

5. FINALS

5.1. FINALS ELIGIBILITY – PREMIER DIVISION

- 5.1.1 To be eligible to participate in the Premier Division finals, players must have been listed as taking the court in 33% of preliminary round matches (rounded up to the nearest whole number). These matches may be accrued in any PVL Division.
- 5.1.2 Byes will not be counted towards matches played when determining eligibility for finals.
- 5.1.3 Each Affiliate may submit a list of Elite players before Round 4 whom they wish to be considered eligible for Premier Division finals only (subject to By-Law 4.1). These Elite players are considered to be AIS/COE/AVA-based or overseas players that are unable to qualify to play in PVL Finals through the PVL regular season due to these commitments.
- 5.1.4 In the event that Elite players are added to either the indoor or beach national program after the PVL season has commenced, players may be added to or withdrawn from the Elite player list subject to suitable documentary evidence being presented to the PVL Control Committee. This must be done within four (4) weeks of the players commencing their involvement with the national program. Amendments may only be made up to the end of Round 6.
- 5.1.5 Elite players listed for the finals (under By-Law 5.1.1) must have gained eligibility for finals with their listed Affiliate in the previous season of the Premier Division, to be eligible for the finals. Previous seasons will only be considered if continuity of registration is evident with the Affiliate, up to the current season (i.e. registered each year, and no transfers intra- or interstate).
- 5.1.6 By-law 5.1.4 does not apply to Elite Junior Players (U19 National Indoor or Beach players) in their first season of PVL competition; however they must still be registered on the Elite Player List by their club.
- 5.1.7 If a player has not competed in the appropriate number of matches, a Club may apply for an exemption for the player to participate in PVL Finals only. Written exemptions will be treated on its merits. Exemptions must be submitted to the PVL Competition Manager, by close of business (5:00pm) on the Monday before the final series begins.

5.2. FINALS ELIGIBILITY – DIVISION 1, 2 or 3

- 5.2.1 To be eligible to play in the finals, a player must have played at least 33% of preliminary round matches (rounded up to the nearest whole number). These matches may be accrued in the Division the player seeks to play or any 'lower' Division.
- 5.2.2 Byes will not be counted towards matches played when determining eligibility for finals.
- 5.2.3 Players in the Premier Division "Top 6" are ineligible for Division 1 and those in the "Top 8" are ineligible for Division 2 or 3.
- 5.2.4 Players in the Division 1 "Top 6" are ineligible for Division 2 or 3.
- 5.2.5 Players in the Division 2 "Top 6" are ineligible for Division 3.
- 5.2.6 Division 1, 2 or 3 players are allowed to play in their Premier Division team finals series.
- 5.2.7 If a player has not competed in the appropriate number of matches, a Club may apply for an exemption for the player to participate in Division 1, 2 or 3 only. Written exemptions will be treated on its merits. Exemptions must be submitted to the PVL Competition Manager by close of business (5:00pm) on the Monday before the final series begins.

5.3. FINALS ELIGIBILITY – PREMIER JUNIOR

- 5.3.1 To be eligible to participate in the Premier Junior finals, players must have played at least 33% of preliminary round matches (rounded up to the nearest whole number). Nb Matches played in the JPVL are not considered in this calculation.
- 5.3.2 Byes will not be counted towards matches played when determining eligibility for finals.
- 5.3.3 If a player has not competed in the appropriate number of matches, a Club may apply for an exemption for the player to participate in the Junior Division only. Written exemptions will be

treated on its merits. Exemptions must be submitted to the PVL Competition Manager by close of business (5:00pm) on the Monday before the final series begins.

5.4. FINALS FORMAT

- 5.4.1 All finals matches (exc Premier Junior) will be played as best of five (5) sets, with a rally point scoring system. The first 4 sets will be played to 25 points with a 2 point advantage. The fifth set will be scored to 15 points (with a 2 point advantage). No cap is applied to any set.
- 5.4.2 Premier Junior finals matches will be played in the same format as outlined in by-law 6.1.3.
- 5.4.3 Teams that breach By-Law 4.1.7 in finals matches will automatically forfeit all sets in which the illegal or ineligible player took the court.
- 5.4.4 In case of a forfeit during the finals, the offending team may be eliminated from the finals series. Only teams that have fulfilled their finals commitments, including duty, will be eligible for any medals or awards.

6. MATCH REGULATIONS

6.1. FORMAT

- 6.1.1 Unless otherwise stated in these By-Laws, all matches will be conducted under the FIVB 2017-2020 International Rules of Volleyball.
- 6.1.2 Premier, Division 1, 2 & 3 matches will be played as best of five (5) sets, with a rally point scoring system. The first four (4) sets will be played to 25 points with a 2 point advantage. The fifth set will be scored to 15 points (with a 2 point advantage). No cap is applied to any set.
- 6.1.3 Premier Junior
 - a) All round matches are best of five (5) sets within the time frame 80 minutes. No set will start if the match is in the last five (5) minutes of time-limited matches.
 - b) No time outs or substitutions can be called in the last five (5) minutes.
 - c) Incomplete sets will count as a set won if a team has 13 or more points (8 in the deciding set) and leads by two (2) or more points.
 - d) Any match (including semi-finals and medal matches) that is tied on sets will be awarded to the team that scored the most points in the match, if still drawn the winner will be the team that won the last point played.
 - e) If the Referee has whistled for service prior to the siren for end of match, then that rally must be played, and shall count toward the scores. The 1st Referee alone shall determine whether the whistle preceded the siren.
- 6.1.4 The 12 Substitution Rule will be used in all Divisions.
- 6.1.5 Matches will be played under the GEST (Guaranteed Earliest Starting Time) system. This means that if matches run over the scheduled finishing time, the next match does not start until 15 minutes after the previous match. If the match finishes more than 15 minutes before the next scheduled match, that match will not commence until the scheduled starting time. For junior matches this is 10 minutes.
- 6.1.6 If a team due to play was involved in the match immediately prior, both teams will receive an additional five (5) minutes changeover time, resulting in 20 minutes from “last whistle to first whistle” between matches. This time includes the warm-up protocol. For junior matches this is 10 minutes.
- 6.1.7 Each team is allowed a maximum of three (3) team officials on the bench (e.g. Coach, Assistant Coach & Manager).
- 6.1.8 The 2021 PVL match ball is the Mikasa V200W.
- 6.1.9 The net heights are as follows:

Male Divisions	2.43m
Female Divisions	2.24m

6.2. PLAYER RECORDS

6.2.1 All clubs are to utilise VQ's Affiliates On Line (AOL) to allocate their registered eligible players and coaches to teams to compete in each round of play.

6.3. FORFEITS AND LATE STARTS

6.3.1 All matches (first serve whistle) will commence at the time advised in the official draw or fifteen (15) minutes after the completion of the previous match on that court, whichever is the later. This time includes the warm-up protocol. For junior matches this is 10 minutes.

6.3.2 If a team is not ready to start at the advised time, it forfeits the first set. If, after ten (10) minutes, the team is still not ready to commence, it forfeits the second set. Once a further ten (10) minutes has elapsed, i.e. 20 minutes after scheduled start time, a match forfeit will be recorded. Teams will incur fines for the sets forfeited.

6.3.3 When neither team is ready to commence at the advised starting time, both teams forfeit the first set. If neither team is ready to start after ten (10) minutes, both forfeit the second set and a double match forfeit will be recorded once a further ten (10) minutes has elapsed, i.e. 20 minutes after scheduled start time.

6.3.4 Where both teams have forfeited the first set but are then ready to play at the start of the second set, the match shall be played as a best of three (3) sets.

6.3.5 Where both teams have forfeited the first and second sets but are then ready to play at the start of the next set, the match will consist of one (1) set to 25 points.

6.3.6 The Venue Manager reserves the right to permit matches to commence late without penalty, due to unforeseen problems e.g. Notified traffic accidents, major events.

6.3.7 The Venue Manager or Chief Referee may give permission for a Libero to be re-designated as a normal court player in order to avoid a forfeit in the case of an injury.

6.4. RESCHEDULED MATCHES

6.4.1 All requests for a match to be rescheduled for whatever reason should be emailed to the PVL Competition Manager and the opponent at least 2 weeks in advance.

6.4.2 A response is required a minimum of 9 days before the scheduled match.

6.4.3 These matches will be held no later than 2 weeks after the scheduled match and will be held at a venue approved of by the non-requesting team. The requesting team is responsible for organizing the venue (at their cost) and the officials /duty team(s). Forfeits will apply to teams that do not comply.

6.4.4 The requesting team is also responsible to cover any scheduled duty of the non-requesting team in the pertinent round.

6.4.5 Where a match has been rescheduled at VQ's request, there will only be 1 option provided after consultation with the teams involved. Failure to comply with this request will result in a forfeit being applied.

6.5. UNIFORMS

6.5.1 All players must wear a uniform, complete in the following details:

- a) Each shirt must have permanently fixed to the front and back – a unique number between 1 and 99. The number should be a minimum of 15cm on the front and minimum 20cm on the back.
- b) Numbers on the front right hand side of the shorts are also encouraged.
- c) The colour and design of the shirt must be consistent throughout the team.
- d) Male players must wear shorts consistent in colour, trim and style.
- e) Women's teams are allowed to wear shorts, sports briefs or bike pants, providing the uniform is consistent throughout the team in terms of colour.
- f) The manufactures brand/logo must not exceed 10cm x 10cm unless the marking is consistent across the team, including stripes on shorts.

- g) Sponsors logo must be consistent across the team.

6.6. OFFICIALS

- 6.6.1 QVRC will roster a Chief Referee for each round.
- 6.6.2 Duty teams must provide a 1st Referee, a 2nd Referee, two (2) standing Lines persons and one (1) Scorer.
- a) All qualified referees overseeing PVL matches are encouraged to wear the VA Referee Shirt (sky blue colour).
- b) In Premier Division & Division 1, the 1st Referee provided by the Affiliate must be a VA-accredited Level 2 Badge Referee or higher. If the Referee is a current accredited Level 2 Referee and is wearing a VA Referee Shirt (sky blue colour) whilst refereeing the match, they will be eligible for reimbursement of their expenses to officiate the match by VQ.
- c) In all other Divisions as part of the team's duty responsibility, the 1st Referee provided by the Affiliate must be a VA-accredited Level 1 Badge Referee or higher.
- 6.6.3 QVRC may, from time to time, nominate/roster a development Referee to officiate Premier Division matches. This nomination will be made in writing to advise the Affiliate designated to the duty, no later than the Friday preceding the round.
- 6.6.4 All teams in the Junior Divisions must ensure that there is a responsible adult available to supervise their Junior Referees during duty.
- 6.6.5 Duty teams without a minimum of five (5) players reporting to the Venue Manager or Chief Referee at the Scorer's bench at the coin toss (7 minutes from the start of the match) will be fined \$20 for each player missing. The 1st Referee is then responsible for the match starting on time. Once the match commences, any duty team shortfall will see this fine increased to \$50 for each player missing.
- 6.6.6 Duty teams must ensure that the score sheet is completed in accordance with the 'checklist' on the Scorer's bench. The 'checklist' is also available from the Venue Manager.
- 6.6.7 All Scorers and Lines people are prohibited from using mobile phones and other electronic devices during the match.

6.7. PLAYER / COACH / SPECTATOR BEHAVIOUR

- 6.7.1 Players, coaches or spectators may be given a written warning by Competition Management in regards to their conduct during competition. This will be emailed to the club contact no later than 5:00pm on the Tuesday following the match in question.
- 6.7.2 Any player, coach or spectator who receives two (2) written warnings within a 5 week period will be;
- a) suspended immediately at the end of the match in which they incurred their second written warning.
- b) suspended from being involved in the same team's next match, which does not include "byes".
- c) cannot be involved in any matches or Divisions until Part b) above is completed.
- 6.7.3 The PVL Competition Manager, Chief Referee and Venue Manager have the power to issue sanctions to players, coaches and spectators as they deem appropriate.
- 6.7.4 Any player, coach or spectator who receives two (2) Red Cards within a 5 week period, excluding time delay sanctions, will be:
- a) suspended immediately after the match in which they incurred the second sanction.
- b) suspended from being involved in the same team's next match, not including "byes".
- c) cannot be involved in any matches or Divisions until Part b) above is completed.
- 6.7.5 Any player, coach or spectator who is sanctioned with expulsion (Red & Yellow together) will be:
- a) suspended immediately from the match in which they incurred the sanction.
- b) suspended from being involved in the same team's next match, not including "byes".
- c) cannot be involved in any matches or Divisions until Part b) above is completed.

- 6.7.6 Any player, coach or spectator who is sanctioned with disqualification or expulsion will be cited to appear within 5 days at a VQ Judiciary Committee hearing at Sports House Milton at the discretion and direction by the VQ General Manager.

7. COMPETITION STANDING, PENALTIES AND PAYMENTS

7.1. PREMIERSHIP POINTS

7.1.1 Premiership points will be awarded in all Divisions as follows:

- a) 3 points for a win.
- b) 1 point for a loss.
- c) 1 point for each set won.
- d) 0 points for a bye.
- e) -2 points for a forfeit.

7.2. PREMIERSHIP TABLE

7.2.1 The ranking of teams on the premiership points table is determined in this order:

- a) The most premiership points.
- b) The highest ratio of points won to points played (5 decimal places).
- c) The highest ratio of sets won to sets played (5 decimal places).
- d) Result of the last match between the two (2) teams.

The set/point quotient equation is as follows:
$$\frac{\text{Points Won}}{\text{Points Played}} \times 100$$

7.2.1 If for any reason the number of matches played by teams in a Division is not equal, then competition standings will be determined by average competition points earned per match.

7.3. PENALTY BOND

7.3.1 All Affiliates participating in PVL will be required to pay a penalties bond for all teams, which will be refunded at season end, minus any fines accrued (plus any funds received from forfeits).

Team bonds are set at the following rates:

Existing club team	\$150 per team inc. GST
New club in 1 st year	\$300 per team inc. GST
Late payment of bond may incur a \$100 fine per team inc. GST	

7.3.2 Clubs/associations are subject to fines as follows;

- a) \$20 for each player not in correct uniform (By-Law 6.5.1).
- b) \$20 for each duty team default (By-Law 6.6.5), increasing as per the By-Law.
- c) \$60 for an incorrect, incomplete or substandard score sheet by the duty team. (By-Law 6.6.6).
- d) \$60 point for "player not listed" and "Libero incorrectly listed" will be applied to the duty team.
The offending team may also be penalised if the fault is due to their error. These penalties will only apply if discovered after the conclusion of the match. The match result will stand.
- e) \$50 per day for delayed submission of score sheets from re-scheduled matches.
- f) \$20 for a one (1) set forfeit, \$50 for a two (2) set forfeit (By-Law 6.3.2 and 6.3.3).
- g) \$100 in the case of a match forfeit (By-Law 6.3.2, 6.3.3).
- h) \$40 penalty for not having an appropriate standard of Referee.
- i) \$30 penalty for not leaving the team benches in a clean and tidy manner as judged by the Venue Manager. The sides chosen at the start of the match will designate each team's area of responsibility.
- j) \$150 for non-attendance at Pre/Post season meetings.
- k) \$100 for non-attendance at Pre Season Referees Workshop.

- 7.3.3 A fine notification will be sent to the Affiliate's primary contact via email. The fine notice will explain the details of the infringement. All fine amounts include GST.
- 7.3.4 Match forfeit fee (\$100) will be credited to the bond of the non-offending team where applicable.
- 7.3.5 Where a match is not played as a result of a forfeit, there will be an escalating penalty.
 - a) 1st offence – fine only.
 - b) 2nd offence – fine + 50%. Teams will also have to show cause why they should remain eligible for finals.
 - c) 3rd offence – 2 x fine. Teams will be ruled out of finals and will be suspended from the competition for the following year.
- 7.3.6 A fine only will apply to matches that are played and then deemed a forfeit due to illegal players, etc. Forfeits of this type will not attract the escalating penalty.

7.4. PAYMENTS

- 7.4.1 The 1st Referee for Premier Division & Division 1 matches expense reimbursement is \$35, subject to their complying with outfitting and accreditation standards.
- 7.4.2 For Finals matches of all senior Divisions the 1st and a 2nd Referee and 1st Referee for Junior Finals matches the expense reimbursement is \$35 per for best of 5-set matches, \$25 for best of 3-set matches subject to their complying with outfitting and accreditation standards.

8. CLUB CHAMPIONSHIP

- 8.1. The PVL Club Championship will be awarded to the club with the most Club Championship points at the end of the season. Club Championship points will be allocated in two (2) parts:
 - 8.1.1 Participation Points - a base level of points awarded for entering a club's first team in that Division; and
 - 8.1.2 Placing Points - determined by the team's finishing position in that Division.
- 8.2. Clubs with more than one (1) team entered in a Division will only receive "Placing Points" for their highest finishing club team in that Division. The points corresponding with the second club team's position are "sterilised" and lower-placed teams do not move up the "Placing Points" table.
- 8.3. Club Championship points table

- 8.4. Totals are calculated at the end of all finals matches.
- 8.5. If Associations are tied on Club Championship points, then they will be determined by the following sequential criteria:
 - a) Premier Division premiership points.
 - b) Premier Division points ratio (5 decimal places).
 - c) Premier Division set ratio (5 decimal places).

9. AWARDS

- 9.1. Each Division will receive medals/trophies for finishing first, second or third. An annual trophy for each Division's champion team will also be presented to the winners of each Division. A perpetual trophy is presented and is given back to VQ prior to the start of the next season.
- 9.2. A "Most Valuable Player" award will be distributed to a player in each Division who has accumulated the most points during the regular season. The 1st Referee will award points on a 3 points and 1 point basis, with the 3 points going to a player on the winning team.
- 9.3. Players listed in the "Top 6/8" are ineligible to win the MVP in the respective lower Divisions.
- 9.4. There will be a MVP awarded to the player of the match in all Grand Finals. This will be voted on by the two (2) match Referees.

10. MANAGEMENT OF THE COMPETITION

- 10.1. The PVL is overseen by its Control Committee, which comprises the PVL Competition Manager, the VQ Sport Operations Manager and VQ staff member responsible for the PVL. The Control Committee's role is to conduct the PVL within the terms of these By-Laws, the VQ Constitution and the rules of the game. The Control Committee reports to the VQ General Manager.
- 10.2. VQ's responsible staff member and office is to manage all financial aspects of the PVL, venue bookings, equipment allocations and dissemination of information to ensure the smooth operation of the PVL. They will recruit additional staff to support delivery of the PVL as needed.
- 10.3. The PVL Competition Manager is responsible for the production of the PVL draw, recording and updating of the premiership points table, details of matches played by players to determine eligibility for finals, or ineligibility to play in another team/grade and the issuing of fines and penalties for any infringements.
- 10.4. The Venue Manager is responsible for the efficient running of a PVL venue on a week to week basis. They will coordinate match delivery, liaise with teams, venue staff and ensure all equipment is in place, accounted for and arrange for scoresheets, results, incident and required reports to be submitted at the conclusion of each round of matches to the VQ office. Should an "on the spot protest resolution" be required they will liaise with the Chief Referee or Referee Supervisor in implementing the procedure.
- 10.5. The Chief Referee is to create and submit a roster of referees to reach the VQ office by midday each Thursday before a round of play for dissemination to clubs. They will attend to or delegate to a referee supervisor (with the VQ responsible staff member approval), the appointment of Referees if one (1) is not provided by the duty team and implementing the "on-the-spot Protest Resolution" procedure.

11. PROTESTS, APPEALS & REFERRALS

- 11.1. A match protest will be resolved using the "on the spot protest resolution" guideline. Match protests are not subject to further appeal.
- 11.2. An appeal regarding score sheet penalties and ineligible players must be received by the PVL Competition Manager, within 3 business days of receipt of the breach notice.
- 11.3. Matters concerning discipline (Section 6.7) will be referred to the VQ Judiciary Committee for action as outlined in VQ's "Complaints Handling Procedure".
- 11.4. Appeals against a decision of the PVL Control Committee must be lodged with VQ's General Manager within 3 days of receiving a decision in accordance with VQ's "Complaints Handling Procedure".
