**I hereby apply for membership of Volleyball Australia Ltd. (VA). In so doing and in consideration of my application for membership being accepted, I acknowledge and agree that:**

1. **"VA"** for the purposes of this membership application and declaration, means and includes Volleyball Australia Ltd., its members (including Member States and State Affiliates) and where the context so permits, their respective directors, officers, members, servants, or agents.
2. **If accepted I will be a member** of the club/association/competition entered into the "Club" or "Other" field of this membership application form, and a member of VQ and VA.
3. **This document cannot be amended.** If I do amend it my application will be null and void.
4. **Insurance** is in place that provides limited cover to me whilst I am performing or participating in any authorised or recognised VA Activity. *(For insurance details contact [VQ – 07 3367 1991].)* I can, in my own interests, seek and obtain personal insurances over and above the cover provided by VA.
5. **The VA Constitution** is a contract between VA and me. I will be bound by it and any By-Laws and policies made under it. It is necessary and reasonable for promoting VA, and volleyball. For the avoidance of doubt, I acknowledge and agree to comply with the Constitutions, By-Laws and policies of VA, Volleyball Queensland, and the club/association/competition entered on this membership application, provided my application is accepted. I acknowledge and agree that I will be bound by and must comply with all Volleyball Australia Policies, including but not limited to, the National Integrity Framework and associated integrity policies, Anti-Doping Policy, Code of Conduct and Social Media Policy which can be found here – <https://volleyball.org.au/integrity/policies/> I acknowledge that I am bound by these policies and it is my responsibility to be familiar with these policies. I acknowledge and agree that a breach of these policies could result in disciplinary action being taken, as outlined in the complaints or discipline procedures for the respective policy.
6. **Warning:** Volleyball can be inherently dangerous. Serious accidents can and often do happen which may result in me being injured or even killed. I have voluntarily read and understood this **warning** and accept and assume the inherent risks in volleyball.
7. **Exclusion of Liability:** Except where provided or required by law and such cannot be excluded, I agree that it is a term of my membership (if accepted) that VA is absolved from all liability however arising from injury or damage however caused (whether fatal or otherwise) arising out of my membership and/or participation in any VA Activity.
8. **Release and Indemnity:** In consideration of VA accepting my application for membership I:
  - (a) release and forever discharge VA from all Claims that I may have or may have had but for this release arising from or in connection with my membership and/or participation in any VA Activity; and
  - (b) indemnify and hold harmless VA to the extent permitted by law in respect of any Claim by any person including but not only another Member of VA arising because of or in connection with my membership and/or participation in any VA Activity.

In this **clause 8 "Claims"** means and includes any action, suit, proceeding, claim, demand, damage, penalty, cost or expense however arising but does not include a claim in respect of any action, suit, etc. made by any person entitled to make a claim under a relevant VA insurance policy or under the VA Constitution or any By-Laws.
9. **Fitness to Participate:** I declare that I am and must continue to be medically and physically fit and able to participate in any VA Activity. I am not and must not be a danger to myself or to the health and safety of others. I will immediately notify VA in writing through my VQ Affiliate or VQ, of any change to my fitness and ability to participate. I understand and accept that VA will continue to rely upon this declaration as evidence of my fitness and ability to participate.
10. **Information:** I have provided the information required in this on-line application. I warrant that all information provided is true and correct.
11. **Privacy:** I understand the information I provided herein is necessary for the objects of VA. I acknowledge and agree that the information will be disclosed by VQ to my VQ Affiliate and VA and will only be used for the objects of VA, my VQ Affiliate, VQ and VA general business, and to provide me with membership services. I understand that I will be able to access my information through my VQ Affiliate and/or VQ. If the correct information is not provided, my membership application may be rejected. I acknowledge that VA may also use my personal information for the purposes of providing me with promotional material from VA sponsors or third parties. I may advise VA if I do not wish to receive from VA any VA sponsors or third parties' promotional material.
12. **Copyright and right to use image:** I acknowledge and consent to photographs being taken of me during my participation in VA Activities. I acknowledge that the photographs are owned by VA and that VA may use the photographs for promotional or other purposes without my further consent being obtained. Further, I consent to VA using my name, image, likeness, and my performance in VA Activities, at any time, to promote the VA Activities by any form of media. I may advise VA if I do not wish VA to use my name, image, likeness, and my performance in this way.
